Hoffwn ddiolch i chi am eich gohebiaeth yn ddiweddar ynglŷn â Phrosiect Traphont Abermaw ac am roi cyfle i swyddogion yr Awdurdod gael dysgu mwy am y prosiect.

Thank you for your recent correspondence regarding the Barmouth Viaduct Project and affording officers from my Authority an opportunity to learn more about the project.

Rwy'n deall, ac yn gwerthfawrogi, eich pryderon ynglŷn â chyflwr presennol y mynediad i/o Lwybr Mawddach (ger yr aber) i mewn i Abermaw. O'r sgysiau a gefais ynghylch y prosiect gyda'r swyddogion perthnasol, ni allaf ond mynegi ein cefnogaeth am brosiect a fydd yn arwain at bwynt mynediad sy'n fwy diogel ac addas.

I understand and appreciate your concerns regarding the present condition of access to and from the estuary-end of the Mawddach Trail into Barmouth. From the conversations I've held with relevant officers regarding the project, I can only express our support for a project which will lead to a safer and more suitable access point.

Yn ychwanegol at ystyriaethau diogelwch a mynediad, gallai adeiladu'r draphont arfaethedig ddod â buddion cymdeithasol ac economaidd pellach i Abermaw a'r cymunedau eraill sydd gerllaw - gan gynnwys y rhai ym Mharc Cenedlaethol Eryri. Er bod y safle dan sylw y tu allan i ffin y Parc Cenedlaethol, mae'n amlwg yn gysylltiedig â'r Lwybr Mawddach poblogaidd, ac mae ganddo gysylltiadau anffurfiol â Ffordd Ardudwy; gan hynny, byddai'r Awdurdod yn falch o barhau i fod yn gysylltiedig â'r prosiect.

In addition to safety and access considerations, construction of the proposed viaduct could bring further social and economic benefits to Barmouth and other nearby communities – including those within Snowdonia National Park. Although the site under consideration is beyond the National Park boundary, it is inexorably linked to the popular Mawddach Trail and has informal linkages to the Ardudwy Way; with this being the case, the Authority would be pleased to continue its association with the project.
